

SNAPP® screen Track LIMITED WARRANTY

ScreenPorch.com, Inc. warrants the SNAPP® screen Track (hereinafter referred to as the "Product"), to be free of defects in material and workmanship, subject to the limitations and conditions herein listed. During this limited warranty period ScreenPorch.com, Inc. will, at its discretion and free of charge, repair or replace any Product, which is found to be defective in material or workmanship due to normal use.

This limited warranty, as with most other home products, fixtures and appliance manufacturers' warranties, is based on time not usage. This limited warranty does not cover failure to function or any damage(s) whatsoever resulting from or caused by, without limitation to, unreasonable or improper use, abuse, misapplication, or damage inflicted by you, a shipper or any other third party, or improper installation, failure to provide reasonable and necessary maintenance, failure to follow written installation, operating or maintenance instructions provided with Product, if any.

ScreenPorch.com, Inc. is the Product manufacturer not the Product installer. This limited warranty does not cover, in any manner or form whatsoever, either whole or in part, the installation of Product or any failure to function or any damage(s) whatsoever resulting from, or caused by, the installation or improper installation of Product. ScreenPorch.com, Inc. will not be responsible for any other associated or additional costs including, but not limited to, costs associated with the removal, installation and/or reinstallation of the Product in question.

Warranty, limitations and conditions for aluminum Product: A twenty (20) year limited warranty is provided and is contingent upon Product being installed in areas of normal weather and atmospheric conditions. This limited warranty does not apply in any fashion whatsoever to damage or failure caused by, salt spray or proximity to seacoast, blowing sand or debris, chemical or foreign atmospheric substances, installation of Product in direct contact with pressure treated materials, fire, any act of god, vandalism, terrorism, harsh or caustic cleaners, power washing, power or hand scrubbing or sanding, painting, refinishing, as well as gouges or scratches of any kind or cause or any other condition, exposure, or experience that may damage applied finish or exposes bare aluminum. It is the responsibility of the consumer to establish the original purchase date for warranty purposes.

Warranty, limitations and conditions for PVC Product: A five (5) year limited warranty is provided and is contingent upon Product being installed in areas of normal weather and atmospheric conditions. This limited warranty does not apply in any fashion whatsoever to damage or failure caused by UV exposure, freezing, extended freezing, subzero temperatures, blowing sand or debris, chemical or foreign atmospheric substances, fire, any act of god, vandalism, terrorism, harsh or caustic cleaners, power washing, power or hand scrubbing or sanding, painting, refinishing, as well as gouges or scratches of any kind or cause or any other condition, exposure, or experience that can weaken PVC.

The protection under this Limited Warranty is provided to the original purchaser only and is not transferable to any subsequent purchasers or owners who acquire the Product or the structure in which Product is installed.

It is the responsibility of the purchaser to establish the original purchase date for warranty purposes.

THIS WARRANTY IS EXCLUSIVE AND REPLACES ALL OTHER WARRANTIES, CONDITIONS, REPRESENTATIONS, AND GUARANTEES, WHETHER EXPRESS OR IMPLIED, WHETHER BY STATUTE, AT LAW OR IN EQUITY, INCLUDING ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR USE OR PURPOSE.

This written warranty is your exclusive warranty from ScreenPorch.com, Inc. and represents the SOLE REMEDY available to any owner of SNAPP® screen Tracks for any defects in material or workmanship. ScreenPorch.com makes NO OTHER REPRESENTATIONS, CONDITION, GUARANTEE, OR WARRANTY of any kind other than that stated herein.
